



**Instructions for completing the application for the
AXA Achievementsm Scholarship, in association with U.S. News & World Report**

To complete the application online:

- You must use Microsoft Word version 97 or above.
- You must save the blank application form in Word to your own folder, disk/CD or hard drive. Otherwise, your information will not be saved.
- After saving the blank application to your personal file, fill in the form by using the “tab” key to move between fields as you enter information.
- **PRINT OUT THE APPLICATION AND MAIL IT TO THE ADDRESS LISTED ON THE APPLICATION.**

If you prefer, print the blank application and complete it by hand using a black or blue ink pen or a typewriter.

PLEASE NOTE:

All applicants must print pages 5 and 6 of the application and submit them to the appropriate individuals for completion. These pages contain the transcript information and applicant appraisal.



THE PROGRAM

The AXA Achievementsm Scholarship offers college scholarships of \$10,000 and \$25,000 to high school seniors who have demonstrated outstanding achievement in their activities in school, the community or the workplace. The scholarships are sponsored by the AXA Foundation, in association with U.S. News & World Report.

Applicants must -

- be United States citizens or legal residents,
- be current high school seniors who plan to enroll full-time in an accredited two-year or four-year college or university in the United States by fall 2011 (enrollment at an accredited postsecondary institution outside of the United States will be considered on a case-by-case basis),
- demonstrate ambition and self-drive as evidenced by outstanding achievement in an activity in school, the community or the workplace, and
- be recommended by an unrelated adult who can attest to the student's achievement.

AWARDS

Fifty-two students, to be known as AXA Achievers, will be selected to receive \$10,000 scholarships, one from each state, the District of Columbia and Puerto Rico.

From among the state recipients, 10 students will be named national AXA Achievers. They will be selected to receive additional national awards at \$15,000 each for a total of \$25,000 per national recipient.

AXA Achievementsm Scholarships must be used for education-related expenses for undergraduate study only. Awards are not renewable; however, recipients may arrange to receive payment in installments over multiple years as long as the student continues to enroll in an undergraduate course of study.

Eligible students are encouraged to apply for all AXA-sponsored scholarships, but a student may receive only one AXA-sponsored scholarship. *For more information about all AXA Achievementsm scholarships, visit www.axa-achievement.com.*

CRITERIA

Applicants are asked to **describe in detail** an outstanding achievement they have accomplished in a non-academic activity or project. The accomplishment may be a long-term achievement, an activity or a project that occurred in their school, in the community or in the workplace. Primary consideration will be given to the applicant's demonstrated achievement in a non-academic area as reported by the applicant and supported by the appraisal completed by an adult who is not related to the applicant.

Consideration will also be given to other extracurricular activities in school and community, work experience, and the applicant's academic record over the past four years.

Selection of recipients is made by the administrator of the program, Scholarship America, a national nonprofit student aid and educational support organization. The AXA Foundation may participate in the selection of recipients for the national awards. Selection will not discriminate on the basis of race, color, religion, age, gender, national origin or disability. Consideration will be given to select a diverse group of recipients.

APPLICATION

To apply, print the attached application, complete it and have an adult complete the appraisal. Mail the completed, signed application with a current, complete transcript of grades to:

Applications and required attachments must be postmarked no later than **December 15, 2010**. Grade reports are not acceptable. The first 12,000 applications received, which have met the postmark deadline, will be considered.



APPLICATION, Continued

Applicants are responsible for gathering and submitting all required information in the format requested. Incomplete applications and those not conforming to the required format will be disqualified. Information received is considered confidential and is reviewed only by Scholarship America. The AXA Foundation may participate in the selection of recipients for the national awards. If selected to receive an award, the student must authorize release of scholarship application materials and photographs for use by the sponsor for program promotion and publicity.

All applicants up to 15,000 will be notified by mid-March. Not all applicants to the program will be selected as recipients.

PAYMENT OF SCHOLARSHIPS

Scholarship America will process *AXA Achievement* scholarship payments on behalf of the sponsors. **Payments will be made in equal installments on August 15, 2011 and December 30, 2011 and mailed to each recipient's home address. Checks will be made payable to the school for the recipient's account.**

OBLIGATIONS

Other than as specified, recipients have no obligation to the AXA Foundation and U.S. News & World Report. They are, however, required to supply Scholarship America with complete transcripts when requested and to notify Scholarship America of any changes of address, school enrollment, or other relevant information.

RULES:

Eligibility: No purchase necessary. Employees, financial professionals, or immediate family members of employees or financial professionals of the AXA Group, U.S. News & World Report, Scholarship America, or their affiliates, subsidiaries and advertising and promotion agencies are ineligible to apply.

Application: All sections of the application form and any attachments must be completed in the specified format and include the required signatures. Incomplete applications will be disqualified. The sponsors and Scholarship America will not be responsible for lost, late or misdirected, mutilated, incomplete, illegible or postage-due mail. All applications become the property of the sponsors and Scholarship America and will not be returned or acknowledged. The sponsors and Scholarship America may request additional information or documentation about an applicant. To remain eligible, applicants must provide all reasonably requested documentation and information.

Awards: Awards must be used for education-related expenses at an accredited two-year or four-year college or university in the United States for a full-time course of study. Enrollment at an accredited postsecondary institution outside of the United States will be considered on a case-by-case basis. Full-time study is defined as full-time enrollment for the entire 2011-12 academic year. Awards will be paid in two installments on August 15, 2011 and December 30, 2011 unless a longer payment schedule is requested, up to four years. All checks will be made payable to the school. Taxes, if any, are the sole responsibility of the recipients.

Additional terms: All applicants agree that decisions of Scholarship America are final. To receive the award, recipients agree to authorize release of scholarship application materials and photograph for use by the sponsors for program promotion and publicity. Applicants agree to release, discharge and hold harmless the AXA Foundation, U.S. News & World Report, Scholarship America, and their respective subsidiaries, affiliates, officers, directors and employees, from any and all claims or damages arising out of, in any way, their participation in the program. The AXA Foundation and U.S. News & World Report reserve the right to review the conditions and procedures of this scholarship program and to make changes at any time including termination of the program. Scholarship America, the AXA Foundation and U.S. News & World Report reserve the right to interpret these rules and to make decisions concerning the award, acceptance and use of scholarships in situations not covered by these rules.
